Finance Manager Van Groningen discussed the background behind the mitigation fees. Some discussion took place and the full reading of the ordinance is waived. The total project amount is for \$11,590.00, this is a matching grant, District responsibility \$5,795.00.</u>

Deputy Chief Funk reported that this grant is a dollar for dollar grant to purchase personal protective gear. Director Hanson motioned to adopt resolution 16-23. Director Nelson seconded. **MOTION** passed unanimously after a roll call vote.
