President Grueneberg called the meeting to order at 7:00 p.m. and Operation Support Long led in the pledge of allegiance.

3. <u>Discussion and possible action concerning 2016 Proposed CSDA Bylaws Updates.</u>

After a brief discussion, Vice President Carrington motioned to approve the 2016 Proposed CSDA Bylaws Updates. Director Hanson seconded. **MOTION** passed unanimously with Director Knox and Director Nelson absent.

4. Discussion regarding the 2016/2017 preliminary budget.

Finance Manager Van Groningen reviewed the preliminary budget. He reported the following Revenue changes: 3% increase in secured taxes, 3% increase in the assessment, and 1.5% increase in the special tax. Discussion took place on expenses and the transfer of monies.

5. <u>Discussion and possible action, Resolution 16-08, Transfer of Funds from Fund 722 to Fund 758.</u>

Finance Manager Van Groningen reviewed the resolution to transfer funds from fund 722 to fund 758. The funds in 758 are reserved from the engine payment, but we will be utilizing a portion of them for design and remodel costs for station 84. Director Hanson motioned to adopt Resolution 16-08, transferring \$60,000.00 from fund 722 to fund 758. Director Garrett seconded. **MOTION** passed following a roll call vote with Director Knox and Director Nelson absent.

6. <u>Discussion and possible action, Resolution 16-09, Transfer of Funds from Fund 734 to Fund 722.</u>

Finance Manager Van Groningen reported that we had received the April installment of the special tax into the special tax fund and would like to transfer it to the operating budget. Director Hanson motioned to adopt Resolution 16-09, transferring \$349,022.64 from fund 734 to fund 722. Director Garrett seconded. **MOTION** passed following a roll call vote with Director Knox and Director Nelson absent.

7. <u>Discussion and possible action, Resolution 16-10, Transfer of Funds from Fund 722 to Fund 758.</u>

Finance Manager Van Groningen reported that we received funds over and above staff/personnel costs. He requests transferring the remainder of the funds for future payments for equipment and vehicles. Director Hanson motioned to adopt Resolution 16-10, transferring \$152,600.00 from fund 722 to fund 758. Vice President Carrington seconded. **MOTION** passed following a roll call vote with Director Knox and Director Nelson absent.

8. <u>Discussion and possible action, Resolution 16-11, Budget reclassification from facility</u> maintenance to capital purchase.

Finance Manager Van Groningen reported that the additional maintenance was not utilized and would like to reclassify funds to capital purchase for a copy machine. Director Hanson motioned to adopt Resolution 16-11 reclassifying \$15,000.00 from facility maintenance to capital purchase. Vice President Carrington seconded. **MOTION** passed following a roll call vote with Director Knox and Director Nelson absent.

9. Discussion and possible action, authorizing the Fire Chief or Designee to sign the audit engagement letter with Richardson & Company to perform the FY 2015/2016 Annual Audit.

Finance Manager Van Groningen reported that this is the 3rd year proposal with Richardson & Company and is the same as the prior year FY 2014/2015 annual audit. Director Hanson motioned to authorize Chief Turner sign the engagement letter. Vice President Carrington seconded. **MOTION** passed unanimously with Director Knox and Director Nelson absent.
